## **BRUCI MEMBERSHIP ELIGIBILITY CRITERIA**

---

### **FULL MEMBERSHIP**

An aspiring NA:

- Must fill application forms and be certified
- Must be indigenous informal group located in Uganda although not restricted to Uganda
- Must be voluntary and development oriented in nature
- Must adhere to and sign the BRUCI's code of conduct
- Must show willingness to share information about itself and send progress reports to BRUCI annually.
- Must have been in existence and operational for at least 12 months
- Must have a recommendation from LCI of the area in which the NA is operating
- Should indicate its location of operation and must be visited to verify its existence and suitability
- Above all must pay annual membership fee in the first month of the year at a fee fixed by the General Assembly.

### **FEES TO BE PAID:**

1. Application and membership fees of 100,000 Ugandan shillings to be paid upon application of membership to BRUCI.
2. An annual subscription fee of 100,000 Ugandan shillings to be paid annually.
